Vaughan Mills Code of Conduct

VAUGHAN MILLS, including its designated roadways, and parking lot, is private property. The following Code of Conduct is set forth for the purpose of protecting Vaughan Mills' legitimate business interests and to ensure the safety and security of our customers.

Your entry constitutes your consent to abide by the following rules governing conduct, traffic and parking. The following are not permitted:

1. Using physical force, obscene language, obscene gestures, or racial, religious or ethnic slurs.
2. Physically or verbally threatening any person, fighting, annoying others through noisy or boisterous activities or by unnecessary staring, by following another person through Vaughan Mills or by using sexually explicit language or conduct, or in any other way creating a disturbance which interferes, disrupts or endangers Vaughan Mills patrons or its commercial function.
3. Running, skating, skateboarding, or bicycling on Vaughan Mills' property, obstructing or interfering with the free flow of pedestrian traffic or with other patrons' view of windows and other tenant displays, or assembling for the purpose of disturbing the peace or committing any unlawful act.
4. Using any recreational motorized vehicles or equipment on Vaughan Mills' property, other than those required as mobility aids (i.e.: motorized skateboards or hover boards).
5. Creating litter, spitting, throwing, discarding, or depositing any paper, glass or other matter of any kind on Vaughan Mills property, except in designated trash receptacles.
6. Defacing, damaging or destroying any real or personal property constituting part of or located at Vaughan Mills and belonging to Vaughan Mills, its patrons, or its tenants, including writing, spraying, scratching, or otherwise affixing graffiti on such property.
7. Pets, emotional support, or comfort animals are not permitted in the mall with the exception of service animals or animals in the company of and trained to assist patrons with disabilities.
8. Yelling, screaming or singing, playing of musical instruments, radios or tape players, or otherwise communicating in a manner which creates noise of sufficient volume to impinge on the hearing or peace of other patrons of Vaughan Mills.
9. Engaging in non-commercial expressive activity without the proper prior written permission of Management of Vaughan Mills.
10. Soliciting money or other contributions or donations or distributing commercial advertising or promotional materials of any kind, or offering samples of items which are sold, available for sale, or available in exchange for donation or contribution without the explicit permission of Vaughan Mills.
11. Selling new or used merchandise without permission from Vaughan Mills.
12. Failing to wear shoes or proper attire or wearing apparel which is likely to provoke a disturbance or embroil other groups or general public in open conflict.
13. Sitting on floors, planter, handrails, stairs, trash receptacles, retail mobile carts, kiosks, displays or decorative structures.
14. Possessing any open can, bottle or other receptacle containing any alcoholic beverage, except in areas specifically designated for the consumption of alcohol.
15. Loitering, delaying, lingering, or remaining idle at Vaughan Mills without any useful business for being present.
16. Photographing or videotaping the interior or exterior of Vaughan Mills for commercial purposes or without the explicit permission of Vaughan Mills.
17. Engaging in any unlawful activity or behaviour.
18. Smoking, in any form, including electronic cigarettes, inside Vaughan Mills. Smoking is only permitted in designated exterior smoking areas and must be at least 9 meters from any customer or staff entrance.
19. The consumption of cannabis by any means (including smoking and vaping) is not permitted anywhere on the property, both inside and outdoors.
20. Possession or carrying of any firearms, simulated firearms, or weapons of any kind, openly or concealed, with or without a permit.
21. No commuter parking shall be permitted. Parking areas to be used solely for Vaughan Mills customers while shopping or using Vaughan Mills services.
22. No overnight parking is permitted on the Vaughan Mills property.

This property is monitored to maintain an enjoyable guest experience. This property runs anonymous video analysis used to generate statistics about audience counts on the digital media units.
